NOTICE

Applications are invited from candidates for the post of Conductor on outsource basis. The detailed notice can be seen on the website "<https://sssproviders.com/current-opening/>" and the candidate can apply for the said post online on the website "<https://sssproviders.com/current-opening/>" from 21-04-2025 at 10:00 AM to 30-04-2025 at 05:00 PM.

1. Eligibility Criteria:-

- i. The candidate should have passed Matriculation with second division or should have passed Senior Secondary Part-II Examination from a recognized Institution.
- ii. The candidate should have passed Matriculation with Punjabi as a subject.
- iii. The candidate should have valid Conductor license as on the due date of filing the application.
- iv. The candidate should have valid certificate in First-Aid from a recognized Agency or Authority empowered by The Punjab Government in this behalf.
- v. The candidate's age should be between 18 to 37 years for General category and relaxation in age for SC/ BC will be as per Punjab Government norms.

2. Criteria for selection:-

The candidate will be selected on the basis of marks obtained in Matriculation or Senior Secondary Part-II and for each percentile above 45% 1 merit point will be added e.g if a candidate's score is 46% marks in Matriculation, he will be granted 1 merit point. In case the candidate obtained 70% marks he will be given 25 merit points and so on. Accordingly, the merit will be drawn for different categories. For calculating the merit points, marks obtained in anyone of the qualifying class will be added and the merit will be drawn on the basis of higher marks obtain in any of the class.

**Note:-*

- i. *The candidate should not include additional subjects while calculating the percentage (e.g. the one who has passed Matriculation from PSEB, marks for first 6 subjects shall be taken into account while calculating the percentage. Further, the one who has passed matric from CBSE, percentage should be calculated by multiplying CGPA obtained with 9.5)*
- ii. *The candidate should have to enter upto 2 digits after decimal for entering their percentage. (e.g. if a candidate has obtained 46 percentile it should be mentioned as 46.00., Similarly, if the percentage calculated to be 46.40 it should be entered on a actual figure i.e. 46.40)*
- iii. *The candidate should enter only numerical values for their percentage without any signs.*

3. Place of posting:-

The qualified manpower will be deputed at stations as per the requirement of State Transport Undertaking. The selected manpower shall have to start work at the allotted station failing which his candidature shall stand cancelled.

4. Remuneration:-

- i. The selected candidate will be paid remuneration according to the minimum wages as notified by the Labour Commissioner Punjab from time to time.
- ii. In case the manpower so provided perform duty over and above 8 hours in a day, overtime will be paid in addition to the night allowance as applicable will be paid as applicable to the respective category.
- iii. The selected candidates are entitled for one weekly rest.

**Note: - The above remuneration is subject to Government notifications, rules, regulations, any Act etc, and as per the agreement signed between the agency and the STU.*

5. Important Instructions:-

- i. The applicant must provide the correct information in application form and if it is found at any stage that there is any discrepancy in information provided or the document attached with the application form are tempered, forged or modified in any way then his application shall be rejected straightway.
- ii. The applicant must not have been blacklisted by any State Transport Undertaking.
- iii. The applicant must note that this post is purely on outsourcing basis.
- iv. All the applicants are advised to keep in touch with our website for time to time information till the process is completed.

6. How To Apply:-

- i. The candidate shall visit the website page "<https://sssproviders.com/current-opening/>" for applying online for the said post and no application form will be entertained by hand or through post/ courier.
- ii. The candidate shall click on "APPLY NOW" to apply for required post.
- iii. The candidate shall enter his Mobile No. and the said Mobile No. shall not be changed in any case.
- iv. The candidate must enter his mobile and email on payment gateway and the Mobile No. should be same as previously entered.
- v. The candidate must pay for the required fees (Rs. 100 + GST + Transaction charges) via mode as displayed on screen.
- vi. The applicant shall keep himself ready with original scanned documents (matriculation certificate, Senior Secondary (if applicable), valid conductor license, valid certificate in First-Aid, Aadhaar card, SC/BC certificate (if applicable), latest photograph with white background in file format (i.e. jpg/png maximum size upto 200 KB) before proceeding to file the application form.
- vii. The candidate is required to fill the required information on application form and upload the required documents as per requisite file & size.
- viii. The candidate is required to accept the declaration and click on submit button.
- ix. A system generated message shall be displayed on screen for confirmation of filing of application and the candidate can save the said message or may take print out by pressing CTRL+P.

7. Instructions while filing the application form:-

- i. The candidate/applicant shall in no case change his Mobile No. until the process of filling of vacancies is completed.
- ii. The candidate/applicant must read the notice carefully and submit the application form carefully and the application form once submitted can't be edited/ changed.
- iii. The documents to be uploaded while filing the application form should be clear and readable.
